- iii. Feedback from the curriculum committee has been reviewed, and we have an action plan in place for necessary revisions.

- vi. Plans are underway for the 3rd renewal inspection for our PG courses.
- vii. We are establishing an international student cell.
- viii. It's been advised to engage dental professionals as guest faculty.
- ix. The CIQA will be reconstituted in August 2020, with Dr. C. Srikanth as the coordinator.
- x. Zoom classes for all students are being conducted by faculty members.

The President proposed increasing expenditure on infrastructure and research for the next finacial year. The Coordinator has been tasked with presenting updated infrastructure requirements and research proposals to ensure optimal outcomes in these areas.
