Chittaranjan to present the current academic status of the Institute.

The Principal, Dr. B. Chittaranjan, has given a comprehensive review on the development plans through a detailed PowerPoint presentation, covering the following agenda points for MRIDS (Malla Reddy Institute of Dental Sciences):
