ORDER:

In continuation to the proceedings vide reference 1st cited and as per the reference 3rd cited, Provisional affiliation is hereby granted for **starting of 1st year BDS Course with an intake of 100 (Hundred) seats instead of 50 (fifty) seats at Malla Reddy Institute of Dental Sciences, Hyderabad during the academic year 2013-14.**

The Institution / College is fully responsible to fulfill the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of Dental Council of India.

The number of students admitted should not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Government of Andhra Pradesh / Dr. NTRUHS.

The fee collected by whatsoever name called either for University seats or for Management seats do not exceed the limits specified by the Government of Andhra Pradesh / Dr. NTRUHS from time to time.

The management of the college shall follow the regulations made by the University / Government of Andhra Pradesh in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard may lead to withdrawal of affiliation to the college without any notice.
