**ORDERS:**

As per the provisions of Statute on Affiliation of Dental College for MDS course of KNRUHS-TG, Warangal, the application submitted by **Malla Reddy Institute of Dental Sciences, Quthbullapur, Hyderabad** has been registered with the University. As per the orders of the Hon'ble Vice-Chancellor vide reference 7<sup>th</sup> cited, continuation of provisional affiliation is hereby accorded to the following PG MDS Courses for the academic year 2026-27 with the intake indicated against each, as sanctioned by the Government of India/National Dental Commission vide reference 4<sup>th</sup> cited.

The Institution is fully responsible to fulfill and maintain norms including infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year as stipulated in regulations of NDC (erstwhile DCI).

As per the UGC Regulations vide 7<sup>th</sup> cited and your letter vide ref 6<sup>th</sup> cited, Malla Reddy Institute of Dental Sciences shall be affiliated to Malla Reddy Vishwavidyapeeth, Deemed to be University, Hyderabad from 2024-25 onwards. All the existing students till the academic year 2024-25 will continue to be adhered to the rules and regulations of Kaloji Narayana Rao University of Health Sciences, Warangal, and students taking admission from the academic year 2025-26 will not be under the purview of KNRUHS.

The Management of the college is directed to follow the various instructions issued from time to time by the State Government/ KNRUHS, Warangal in respect of allotment of seats, tuition fee to be collected and any other related issues. Number of students admitted shall not exceed the number of seats permitted by Government of India/ NDC (erstwhile DCI)/ KNRUHS for annual admissions.

The fee collected by whatsoever name called either for University seats or for management seats do not exceed the limits specified by the State Government/ KNRUHS from time to time.

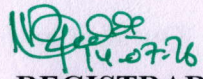
The Principal/ Management of the college shall follow the regulations made by the University/ State Government/ NDC (erstwhile DCI) Regulations in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard will be viewed seriously.

The Principal/Dean of the college is directed to apply for the affiliation of PG MDS Courses till all the last batch of students who were admitted till the academic year 2024-25 complete their course of study. This continuation of affiliation is valid for the students who are already admitted till the Academic year 2024-25 only. This affiliation is not valid to admit any candidate for the intake mentioned above from the academic year 2025-26 onwards.
