This Notification is issued for registration of the candidates to appear for **MDS Part-II (New Regulations) Examinations** commencing from **25.05.2024**.

**Eligibility to appear for MDS Part II (New Regulations) Examinations, May 2024:**

1. The PG Dental Degree students who have been admitted during the academic year 2020-21 into the Dental colleges affiliated to KNRUHS in Telangana state, whose admissions are approved by the KNRUHS and those who have cleared the MDS Part I Examinations are eligible to appear for MDS Part II (New Regulations) Examinations in the month of May 2024.
2. The Candidates of previous batches who have failed, detained and not registered for the said examinations conducted earlier are also eligible to appear for **MDS Part I Examinations** subject to the fulfillment of regulations.
3. The students should put in academic year wise compulsory attendance of **80% (EIGHTY PERCENT)** in each year.
4. Approval of dissertation work is an essential prerequisite for a candidate to appear in the University examination.
5. The Cut-off date for calculation of attendance percentage of the candidates is up to **25.04.2024**.
6. The uploading of the attendance percentage of the candidates is from **01.05.2024** to **03.05.2024**.
7. The confirmation date for uploaded attendance percentage of the candidates is on **05.05.2024**.

**Digital Valuation and Providing only single answer booklet without additional answer booklet:**

The University is a Digital campus and implementing digital valuation for all courses. The MDS Course exam will be conducted with single answer booklet with candidate specific bar code on each page for the candidates appearing for examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer booklet only.

- The candidates shall have to secure a minimum of **50% (FIFTY PERCENT)** marks in MDS Part I examination and shall have to pass MDS Part I examination at least six months prior to the MDS Part II (Final) examination.
- To pass the University Examination, a candidate shall secure in both theory and in practical/clinical including viva voce independently with an aggregate of **50% (FIFTY PERCENT)** of total marks allotted (50 marks out of 100 marks in Part I examination and 150 marks out of 300 marks in Part II examination in theory and 150 marks out of 300 marks in clinical plus viva- voce together).
