Eligibility to appear for MDS Part I theory Examinations, December 2021:

- ➤ As per New Regulations of DCI, The PG; Dental Degree students who took admission into the colleges of Telangana state and whose admissions are approved by the KNRUHS during the academic year 2020-21 and who have completed one year course of study with 80% (EIGHTY PERCENT) attendance shall appear for Paper –I Basic Sciences Examination.
- > The Candidates who have failed, detained and not attempted the earlier examinations are eligible to appear for the MDS First Year Examinations subject to the fulfillment of regulations.
- > The calculation of attendance percentage is up to 20.11.2021.
- The uploading of the attendance of the candidates from 30.11.2021 to 02.12.2021.
- ➤ The confirmation date for attendance is on 03.12.2021.

<u>Digital Valuation and Providing only single answer booklet without additional answer booklet:</u>

The University is a Digital campus and implementing digital valuation for all courses. For MDS Course exam will be conducted with single answer booklet with 64 writable pages with candidate specific bar code on each page for the candidates appearing for examinations and no additional answer book will be issued

to the candidates. The candidates should answer all the questions in the single answer booklet of 64 writable pages only.

Paper – I: There shall be 10 questions of 10 marks each (Total of 100 Marks)

Valuation of Answer books:

All the answer books shall be evaluated by the Internal and External examiners.

University Examination:

Only Basic Sciences paper

There shall be a theory examination in the Basic Sciences at the end of 1st year of the course. The candidates shall have to secure a minimum of 50% in the Basic Sciences and shall have to pass the **PART –I** examination at least six months prior to the final (Part –II) examination.
