## Eligibility to appear for BDS Second year Supplementary Examinations

- The BDS Second year students who have been admitted during the academic year 2018-19
  into the Dental colleges affiliated to KNRUHS in Telangana State, whose admissions are
  approved by the KNRUHS are eligible to appear BDS Second year examinations in the
  month of March, 2021.
- 2. The BDS Second year students who are having 75% of attendance or more and appeared for internal assessment examinations are eligible to appear the examinations.
- 3. The Candidates admitted by KNRUHS during the academic year 2016-17 and 2017-18 who have failed, detained and not written the previous BDS Second year examinations are eligible to appear the examinations subject to fulfillment of regulations.
- 4. Cutoff date for calculation of attendance percentage will be 28.02.2021.
